EDUCATION INNOVATION AWARDS PRINCIPALITY OF ANDORRA

Conditions of the Conec. Andorra Award for pupils

- 1- The goal of the presented work is a project that fosters knowledge and love of Andorra.
- 2- The theme this year focuses on public participation.
- 3- The work presented for the 2021 call must deliver a project of public participation in Andorra that has been carried out.
- 4- The competition is open to students aged from 16 to 25 years educated Andorra or abroad and resident in Andorra, individually or collectively together with a teacher who has guided the creative process of the project, if any.
- 5- The work presented must be original, and must not have received an award in any other competition, nor may it have been presented for any other competition as yet unjudged.
- 6- The work must be presented in Catalan.
- 7- The work must include the following documentation:
 - a. Principal Document including the following sections:
 - Table of contents.
 - Introduction stating the motivation, interest and characteristics of the project and its name.
 - Justification of the project for disseminating its importance among the public.
 - Proposal for its possible reproduction with the aim of reaching the greatest possible dissemination.
 - Explicit list of the goals with the results obtained.
 - Final evaluation of the learning process carried out in the development of the project.
 - b. Complementary Documentation:
 - O List of illustrations in easily accessible digital format showing how the performance of the process of creation of the project developed.
 - O Short presentation of the project in easily accessible digital support,

- maximum 5 minutes, presenting the innovative teaching project and the motivation that led to its presentation for the Award.
- O Attached registration form duly completed with the required information.
- Attached sworn declaration by the student if he or she is of legal age, or of the teacher or legal representative if the student is a minor, showing the following: express statement of the original nature and that it is not a copy, nor a total or partial modification of any other; express statement of ownership of all rights and that the work is free of charges or limitations of the rights of use; statement that the presented work has not been presented to any other competition that is pending resolution at the time of presentation of the work; express statement of acceptance by the author of all the stated conditions of entry; date of the declaration and the original signature.
- O Attached authorisation of assignment free of charge of image rights duly completed by the student if he or she is of legal age, or of the teacher or legal representative if the student is a minor.

The author undertakes to fully indemnify the General Council and the *Associació Gam21* for loss and or damages that these may suffer as a consequence of the inaccuracy or lack of veracity of any of the above-mentioned statements, as well as for the lack of authorisation of assignment free of charge of image rights of the persons who appear in the digital supports that are presented.

8- The originals must be presented in digital format b and email, WeTransfer or any other similar service for hosting and transmitting files to the following email address:

- 9- The period for delivering the work is from 1 May to 31 May 2021, inclusive. Any work presented later than 31 May 2021 will be discarded automatically.
- 10- In a period of no more than fifteen days from the end of the time for delivering the work, the *Comissió Legislativa d'Educació*, Recerca, Cultura, Joventut i Esports (Legislative Committee for Education, Research, Culture, Youth and Sport) will analyse the documentation that has been received and, if it meets the stated conditions, will pass it to the Board.

The Comissió Legislativa d'Educació, Recerca, Cultura, Joventut i Esports will pass the Principal Document, the List of Illustrations and the Short Presentation of the project to the Board in digital format.

- 11- The Board consists of at least four people of renown in the education, social and cultural field, appointed for the purpose by the members of the *Comissió Legislativa d'Educació*, Recerca, Cultura, Joventut i Esports.
- 12- The following evaluation criteria will be taken into account:
 - That the public participation project promotes the construction of an active society.
 - That the public participation project promotes a reiterated practice of values.
 - That the participative process of the public participation project fosters collaboration among different players in society.
 - That the public participation project responds to a real problem.
- 13- The verdict of the Board will be final and irrevocable. It has the power to declare the Award void if the quality of the work does not meet the minimum demanded by a call of this nature. The Board reserves to award, with justification, one or more or second prizes of an overall amount that does not exceed the established available amount.
- 14- None of the originals presented for the Awards within the stated period of acceptance may be withdrawn before the Board publishes its decision. The announcement of the Board's decision will list the presented works.
- 15- The Comissió Legislativa d'Educació, Recerca, Cultura, Joventut i Esports may resolve any query or doubt that may arise in the interpretation of the conditions in the way that it deems most appropriate.
- 16- All the works presented will be eligible for the Award with a prize of €1,500 for the author(s).
- 17- In recognition of the teachers, the Award will be presented on World Teachers Day, 5 October or, if that is not feasible, on the day set by the *Comissió Legislativa d'Educació*, Recerca, Cultura, Joventut i Esports.
- 18- The General Council of Andorra reserves the right to publish the winning works.
